RESOLUTION NO. 2020-

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER, PURSUANT TO SECTION 2-690 EMERGENCY PROCUREMENTS, TO AUTHORIZE ADDITIONAL FUNDING IN THE AMOUNT OF \$50,000 FOR THE PROFESSIONAL SERVICES AGREEMENT WITH BIOCOLLECTIONS WORLDWIDE, INC. TO CONDUCT AND PROVIDE TESTING RESULTS FOR COVID-19 TESTING FOR CITY OF CORAL GABLES RESIDENTS.

WHEREAS, on April 27, 2020, pursuant to Resolution No. 2020-92 and in response to the Novel Coronavirus Disease 2019 pandemic (“COVID-19”), the City Commission authorized the City Manager to enter into a Professional Services Agreement with BioCollections Worldwide, Inc. (“BioCollections”) to conduct and provide results for COVID-19 testing for City of Coral Gables residents in an amount not to exceed \$100,000; and

WHEREAS, under its contract with BioCollections, the City began conducting COVID-19 testing on May 1, 2020 and has been scheduling testing 3 times per week at an average of approximately 120 scheduled appointments for testing per day; and

WHEREAS, additional funding is necessary to continue offering City residents COVID-19 testing to City residents; and

WHEREAS, the City Commission finds that additional testing of City of Coral Gables residents would promote the public health, safety, and welfare of the City.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission authorizes the City Manager to continue utilizing the services of BioCollections Worldwide, Inc. to conduct COVID-19 testing services for the residents of the City of Coral Gables under the Professional Services Agreement approved pursuant to Resolution 2020-92 for an additional amount not to exceed \$50,000.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
