Coral Gables BOA:

Coral Gables is proposing we find an alternative location for the panels on the South Roof Plane that faces Sunset Road.

Current layout: Panels on both the South and East Roof Planes. Majority of the panels are located on the front of the building, where there is NO shading and makes for excellent production. We are utilizing as much of the south roof plane as allowed and the remaining panels are located on the east roof plane, where there is minimal shading.

Relocating the panels from the front of the building to the west roof plane, will significantly diminish the production of the solar system due to the shading from the trees surrounding the property. The only achievable location for the panels, that allows the customer to maximize the production of their system, is leaving the design as is, with panels on the south & east roof planes.

I have included some photos taken from all angles of the property. The photos show the trees surrounding the property and the tremendous amount of shading on the west, north and some of the east roof planes.

The trees do play in our favor for one reason only. The trees surrounding the outer property conceal the panels so they are not visible from Sunset Road.
