PART II: Explanation (Supporting documentation must be attached)

Steiner-Atlantic Corp. is the sole source authorized distributor and full line equipment sales and service for the Milnor gear dryer and extractor. The City of Coral Gables Fire Department is making this purchase for Fire Station 1 and Fire Station 3. The Washer/Extractor and a Gear Drying Cabinet will enable on duty personnel to wash and dry their bunker gear immediately post fire incident. The Milnor 60 lb Capacity Rigid Mount Washer/Extractor with "Gear Guardian" EP Express uses a specialized cleaning and processing of turnout gear, gloves and protective hoods. This machine is equipped with water saving technology as standard with single dry supply chute and a 6 liquid chemical injection processor to ensure the gear is cleaned and sanitized up to the standards of NFPA 1851. The Gear Guardian drying Cabinet is electrically heated, so the airflow penetrates directly providing superior drying performance. The Gear Dryer is specialized as it does not exceed the 102 degree temperature as per the requirements of NFPA 1851. This drying cabinet has the capacity to hold six sets of gear, which will enable most stations to have the ability to wash and dry their gear in a more time effective way. These products from Steiner-Atlantic Corp are electricity and water friendly. These same units were purchased for the Fire Station 2 remodel project. The purchase of the Gear Extractor and Dryer for Stations 1 and 3 will maintain the consistency of product within all Fire Stations giving all personnel the capability of decontaminating their turnout gear in an efficient manner.
