

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2021-219**

A RESOLUTION OF THE CITY COMMISSION ADOPTING THE RECOMMENDATION OF THE TRANSPORTATION ADVISORY BOARD TO BUDGET \$1.2 MILLION DOLLARS FOR PEDESTRIAN INFRASTRUCTURE IN THE FISCAL YEAR 2021-2022 BUDGET.

**WHEREAS**, the Transportation Advisory Board’s (“TAB”) objective is to identify and recommend improvements to all modes of transportation connectivity to provide a variety of transportation alternatives; and

**WHEREAS**, at the July 14, 2021 City Commission Meeting, the TAB presented a resolution to the City Commission requesting the construction of sidewalks at various locations throughout the City where gaps were identified; and

**WHEREAS**, at the July 20, 2021 TAB meeting, the Board adopted a resolution requesting that the City Commission reconsider the original sidewalk funding request made by the Public Works Department for the upcoming fiscal in the amount of \$1.2 million; and

**WHEREAS**, in light of the City receiving federal funds through the American Rescue Plan Act, the City Commission voted to adopt the TAB’s recommendation and budget \$1.2 million for pedestrian infrastructure in the FY21-22 budget;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**SECTION 2.** That the City Commission hereby directs the City Manager to budget \$1.2 million for pedestrian infrastructure in the FY21-22 budget.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
