RESOLUTION NO. 2024-173

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION TO WAIVE THE COMPETITIVE BID PROCESS OF THE PROCUREMENT CODE AS A SPECIAL PROCUREMENT/BID WAIVER FOR THE CONTINUATION OF PROFESSIONAL SERVICES WITH FURIA FLAMENCA FOR DANCE PROGRAMMING AND SERVICES AT THE WAR MEMORIAL YOUTH CENTER, PURSUANT TO SECTION 2-691 OF THE CITY'S PROCUREMENT CODE.

WHEREAS, in 2023 at the request from the public, staff-initiated dance programming services with Furia Flamenca using a Professional Service Agreement using Procurement Code, Section 2-607(24); and

WHEREAS, the community's demand for these dance program services increased to providing more classes and shows as a result of the programs popularity and high quality programming services rendered by the vendor; and

WHEREAS, the program serves more than 100 children at the War Memorial Youth Center; and

WHEREAS, the Community Recreation Department recommends continuing with this contracted dance vendor for programming services in order to provide continuity of operations and high-level services through the Fall/Winter 2024 programming season, which will allow for a formal RTQ process to be initiated; and

WHEREAS, approval of the competitive bid waiver will allow for the continuation of existing programming with Furia Flamenca for contracted dance program services to the community and patrons of the War Memorial Youth Center; and

WHEREAS, Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver" authorizes the Chief Procurement Officer to initiate a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission accepts this recommendation and authorizes the City Manager to waive the competitive bid process for the continuation of contracted dance services with Furia Flamenca for patrons of the War Memorial Youth Center, pursuant to Section 2-691 of the City’s Procurement Code through the Fall/Winter 2024 programming season.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


