**RESOLUTION NO. 2023-41**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING A CHANGE ORDER TO THE CONTRACT WITH COMMUNICATIONS INTERNATIONAL PURSUANT TO SECTION 2-764(B), APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS, OF THE CITY'S PROCUREMENT CODE.

**WHEREAS**, the Police Department, manages and oversees the provision of mission critical radio public safety radio services for the Police and Fire Department along with local government stakeholders; and

**WHEREAS**, the Police Department has determined the need to purchase additional equipment and services for radio infrastructure, equipment, and services; and

**WHEREAS**, the city accessed the Hillsborough County Sheriff's contract in April 2021 under the Chief Procurement Officer's authority for the purchase of Harris Radio equipment and services with Communications International; and

**WHEREAS**, the Police Department is seeking approval for the additional spending authority on the contract to address future needs in the estimated amount of \$595,876 until the term of the existing contract to include any extensions;

**NOW, THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**SECTION 2.** That the City Commission approve the contract modification in the amount of \$595,876 for the duration of the contract, not exceed the available budget for the purchase of additional communication equipment under the contract, pursuant to Section 2-764(b) of the City's Procurement Code.




