**RESOLUTION NO. 2026-30**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD RFP 2025-044 GYMNASTICS PROGRAMMING SERVICES TO TUMBLEBEES GYMNASTICS, THE HIGHEST RANKED RESPONSIVE-RESPONSIBLE PROPOSER, PURSUANT TO FLORIDA STATUTE 2-763 OF THE PROCUREMENT CODE ENTITLED “CONTRACT AWARD”.

**WHEREAS**, on October 31, 2025, the Procurement Division of Finance formally advertised, issued, and distributed Request for Proposals (RFP) 2025-044 Gymnastics Programming Services; and

**WHEREAS**, on November 26, 2025, two (2) firms submitted proposals in response to the RFP: Gym Kidz LLC and Tumblebees Gymnastics; and

**WHEREAS**, on December 19, 2025, the Evaluation Committee convened to evaluate the two (2) responsive and responsible proposals and ranked the firms in the following order: Tumblebees Gymnastics (top ranked), and Gym Kidz LLC (second ranked). The Evaluation Committee determined that Tumblebees Gymnastics was the highest ranked responsive-responsible proposer; and

**WHEREAS**, the Chief Procurement Officer recommends accepting the Evaluation Committee’s recommendation to award and negotiate an agreement with Tumblebees Gymnastics for RFP 2025-044 Gymnastics Programming Services; and

**WHEREAS**, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the Commission accepts the recommendation of the Chief Procurement Officer to award RFP 2025-044 Gymnastics Programming Services to Tumblebees Gymnastics, the highest ranked responsive-responsible proposer, pursuant to Section 2-763 of the Procurement Code entitled “Contract Award”. This authority includes the right to negotiate a final contract for an initial period of three (3) years, with the option to

renew for two (2) additional one (1) year periods in an amount not to exceed the available budget. Should negotiations fail with the highest ranked responsive-responsible proposer, negotiations shall commence with the next ranked firm, until an agreement acceptable to the City has been reached.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
