RESOLUTION NO. 2020-232

A RESOLUTION OF THE CITY COMMISSION APPROVING A TEMPORARY PUBLIC ART LOAN FOR UP TO A YEAR OF A SCULPTURE BY WILLIAM BARBOSA (UNANIMOUSLY RECOMMENDED BY THE ARTS ADVISORY PANEL APPROVAL/DENIAL VOTE: 8 TO 0, AND THE CULTURAL DEVELOPMENT BOARD APPROVAL/DENIAL VOTE: 6 TO 0).

WHEREAS, the Cultural Development Board recommends items of artistic and cultural significance to the City Commission; and

WHEREAS, a proposal for the temporary loan and exhibition of a William Barbosa artwork was submitted to the City through Mayor Valdes-Fauli; and

WHEREAS, the proposed installation of the artwork will be handled through the artist's gallery; and

WHEREAS, the Arts Advisory Panel and Cultural Development Board unanimously passed motions to recommend to the Coral Gables City Commission the temporary public exhibition of William Barbosa's sculpture "Untitled";

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby authorize the temporary public art exhibition, up to a year, of William Barbosa's sculpture "Untitled".

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.






