This serves as a formal request to increase the existing open Purchase Order #002886 for Secure Technologies Integrators Inc. as follows:

They are the Contractor responsible for the installation of the gate access and security system at the Kings Bay Guard House. The original scope of work included the use of cards to provide access through the arm gates. It was after the start of the project that the County requested that transponders would be used in lieu of cards. This resulted in a change to the scope in that special equipment needed to be purchased and installed to make it compatible with other County guard houses.

In addition, the residents through the Homeowner's Association, requested that a license plate camera system be installed to monitor vehicles license plates. This also resulted in additional costs to the Project. The summary of the costs are as follows:

1. Original contract amount	\$24,314.31
2. Change order for special equipment to accommodate the use of transponders	\$8,607.00
3. Change order for license plate camera system	\$2,749.00

The new total contract amount is \$35,670.31

The project has been completed and is being turned over to the County.
