Dear Property Owner and/or Occupant:

This letter constitutes a notice that a violation(s) exists on the premises at:

700 SOLANO PRADO, Coral Gables, FL 33156---2364

The violation(s) found was:

PERMIT - Required for Excavations - Sec. 62-83. - Required.

(a) Violations of this section shall be punishable as provided in section 1-7.  
(b) It shall be unlawful for any person to do work on or cut into, dig up, or excavate for the purpose of laying sewers, water mains, underground wires, or gas pipes, or for setting poles, or any other purpose whatsoever, any of the streets, parks, parkways, sidewalks, alleys, or easements in the city without first securing from the director of public works a permit to do such work, and make such excavations.

Code Enforcement Officer Comments: Installed concrete pavers with gravel in between and a concrete slab with bench, on the city right of way, without a permit. Across the street from 700 Solano Prado.

The following steps should be taken to correct the violation;

Must obtain an after the fact permit or remove and restore swale.

The regulations enforced by the City have been adopted in order to protect the public and assure continuing high property values. Your immediate attention to correcting the violation(s) listed above is required.

The Code Enforcement Division will re-inspect the property on 3/29/2024 to determine if corrective measures have been completed. If the violation(s) has not been completed at the time of inspection, your case will be presented to the Code Enforcement Board for review and possible action. At that time, you will have the opportunity to explain to the citizens serving on the Board the reasons why the violation(s) has not been corrected. The Board has the authority to assess a fine against you for as long as the violation continues.
