RESOLUTION NO. 2011-26

RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A TEN (10) YEAR AGREEMENT WITH MIAMI-DADE COUNTY FOR THE BILLING OF SANITARY SEWAGE AND STORMWATER UTILITY SERVICE CHARGES ON BEHALF OF THE CITY.

WHEREAS, on March 4, 1954 the City of Coral Gables entered into a Sewer Service Charge Collection Agreement with Consumers Water Company; and

WHEREAS, Miami-Dade County is the successor to Consumers Water Company and has assumed all of their obligations, rights and interest; and

WHEREAS, Miami-Dade County, through its Miami-Dade Water and Sewer Department (WASD), operates the water utility system within the City; and

WHEREAS, substantially all of the City's sanitary sewer and stormwater utility customers are customers of WASD; and

WHEREAS, Miami-Dade County has been administering the billing and collection of the City's sanitary sewage and stormwater utility service charges simultaneously with the issuance of the WASD's bills for water service; and

WHEREAS, Miami-Dade County and the City desire to enter into a ten (10) year contract so that WASD can continue to administer the billing and collection of sanitary sewage and stormwater utility service charges on behalf of the City; and

WHEREAS, such contract for services with other governmental entities is exempt from the Procurement Code under Sec. 2-678(25);

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby authorize the City Manager to execute, on behalf of the City, a ten (10) year agreement with Miami-Dade County for the billing of sanitary sewage and stormwater utility service charges on behalf of the City.

SECTION 3. That this resolution shall become effective upon the date of its passage and adoption herein.


