Mayor Lago: Congratulations Mr. Manager, very well done.

City Manager Iglesias: Thank you Mayor. Mayor, Commissioners, we are using this money for two trolley stops to make them ADA compatible and also roof structures to the trolley stop. This is a Last Transit Stop Improvement Program and so, I think we can very effectively use it for a transit system through the trolley system.

Mayor Lago: Thank you Commissioner Anderson for always being an advocate on behalf of ADA issues and leading the charge on that, so I just wanted to recognize you for that.

Commissioner Anderson: Thank you. I spoke with the Manager, although it's a million dollars, doesn't cover the full price tag. We still need to continue our mission in Tallahassee.

City Manager Iglesias: It's about a 45- cover about 55 percent of the cost, so we cover the other 45 percent.

Mayor Lago: We'll get there.

Commissioner Anderson: Okay. Okay. Good work.

Mayor Lago: Listen, I hate to say it, we were always very strong on ADA issues, but you brought a lot of light to that, so that's something that I have to, we've got to give credence to.

Commissioner Anderson: Thank you. Well, I'll move it, so we can.

City Manager Iglesias: We move about 1.25 million people in a trolley per year, so it's a fantastic improvement to our system.

Commissioner Menendez: Second.

Commissioner Anderson: I'll enjoy the roof covering when it's raining.

City Manager Iglesias: There's eight of them.
