## **RESOLUTION NO. 2020-65**

RESOLUTION OF THE CITY **COMMISSION** ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO REJECT ALL PROPOSALS RECEIVED UNDER RFQ 2019-048 FOR PROFESSIONAL TENNIS SERVICES PURSUANT TO SECTION 2-655 OF THE CITY CODE ENTITLED "CANCELLATIONS OF COMPETITIVE BIDS OR PROPOSALS" AND ADVERTISE A NEW RFQ.

WHEREAS, on November 21, 2019, the Procurement Division of Finance formally advertised, issued, and distributed Request for Qualifications (RFQ) 2019-048 Professional Tennis Services; and

**WHEREAS**, fifty-one (51) prospective proposers downloaded the RFQ package from Public Purchase, the City's web-based e-Procurement service; and

WHEREAS, on December 23, 2019, eighteen (18) professionals submitted proposals in response to the RFQ: Federico Acevedo, Franco Alonzo Aller, William Aronson, Luis Jesus Cabrera, Yorgy Carreras, Kevin Chow, Jorge L. Cordova, Reyner Gil, Leandro Gutierrez, Oksana Krutiyenko, John McLean, Alejandro Hernandez Morin, Alfredo Perez, Zoran Radosevic, Daysi Espinal Salazar, Denisse Rheault, Ayaka Terashi and Zurab Zhvania, and

WHEREAS, the Procurement Division, after reviewing the responses to determine responsiveness to the requirements in the RFQ, determined that only eight (8) of the Proposers could be deemed qualified to fill the twenty-five (25) positions available, and

**WHEREAS**, the goal of this RFQ was to qualify at least twenty-five (25) individuals to staff the City's tennis facilities, and

**WHEREAS**, the RFQ had requirements for the different Tiers of Professionals, Tier 1, Tier 2, Tier 3 and Part-Time Professionals, and

WHEREAS, the Procurement Officer recommends that all proposals be rejected and that a new solicitation with revised requirements be advertised; and

WHEREAS, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on City contracts;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE **CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Procurement Officer to reject all proposals received under RFQ 2019-048 for Professional Tennis Services, pursuant to Section 2-655 of the City Code entitled "Cancellations of competitive bids or proposals" and advertise a new RFQ.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
