GENERAL OBSERVATIONS

- 1. PLANS MUST INCLUDE A CURRENT SIGNED AND SEALED SURVEY.
- 2. NEED TO CLARIFY, SITE SURVEY SHOWS A BASKETBALL COURT IN THE LOCATION THAT WAS APPROVED AS A DRIVEWAY. BASKETBALL COURT WILL NOT BE ALLOWED IN THE REQUIRED SETBACKS.
- 3. NEED TO SHOW ENTIRE FLOOR PLAN OF PROPERTY. ADDITION SHOWS A "SERVICE KITCHEN", IS THIS A SECOND KITCHEN? AS PER DEFINITIONS OF A SINGLE-FAMILY RESIDENCE ALL APPLIANCES FOR COOKING MUST BE UNDER ONE CONTROL, AND TO BE OCCUPIED BY ONE FAMILY PLUS SERVANTS, WHO ARE LIVING AND COOKING AS A SINGLE HOUSEHOLD.
- 4. ALL PLANS THAT SHOW A POOL MUST SHOW A ZONING CODE APPROVED POOL ENCLOSURE (SECTION 5-108).
- 5. SITE SURVEY SHOWS EXISTING MECHANICAL EQUIPMENT IN THE FRONT SETBACK. NEED TO VERIFY, AS PER PREVIOUS PERMIT NUMBER 04050054 MECHANICAL EQUIPMENT COMPLIED WITH THE REQUIRED SETBACKS.
- 6. SHEET A-200 STILL SHOWS A TRELLIS IN THE REQUIRED SIDE SETBACKS.
 - A. PLANS SHOW A WOOD TRELLIS IN THE THIRTY (30) FOOT SITE SPECIFIC SETBACK. NEED TO PROVIDE PERMIT NUMBER FOR WOOD TRELLIS. IF NO PERMIT IS FOUND THEN TRELLIS WILL NOT BE ALLOWED IN THE REQUIRED SETBACKS.
