RESOLUTION NO. 2024-167

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE POLICE DEPARTMENT TO WAIVE THE COMPETITIVE BID PROCESS OF THE PROCUREMENT CODE AS A “SPECIAL PROCUREMENT/BID WAIVER” WITH WORKSPACE TECHNOLOGY TO MAINTAIN CONTINUITY OF EXISTING LOCKERS, PURSUANT TO SECTION 2-691 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, Workspace Technologies was originally selected through a formal Competitive Bid process when the Public Safety Building was initially constructed. They were awarded the contract through Procurement via IFB 2020-014 for the Dorm Room Lockers that were installed; and

WHEREAS, to maintain continuity, the same contractor will be utilized. The lockers, total of 51, selected this time will be a complete locker system that includes air conditioning that will match the existing locker system and reduce contaminants in the air; and

WHEREAS, the cost for the purchase of this locker system totals \$133,751.00; and

WHEREAS, the Police Department feels that this request is fair and reasonable as competitive pricing was solicited for each component of the project (lockers and A/C functionality) and the final pricing secured with Workspace Technology was the most cost effective; and

WHEREAS, Section 2-691 of the Procurement Code entitled “Special Procurement/Bid Waiver” authorizes the Chief Procurement Officer to initiate a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission accepts this recommendation and authorizes the City Manager to waive the competitive bid process for the continuity of the dorm room locker system in the amount of \$133,751.00, pursuant to Section 2-691 of the City's Procurement Code.


