A RESOLUTION OF THE CITY COMMISSION AUTHORIZING CONTRACT THRESHOLD EXTENSION TO THE EOUIPMENT AND **AMENITIES** FOR PARKS **AND** PLAYGROUNDS CONTRACT **RFP** 18/19-2 WITH REPRESENTATIVE SERVICES, INC., PURSUANT TO SECTION APPROVAL OF CONTRACT **THRESHOLD** EXTENSION IN THE ESTIMATED AMOUNT OF \$1,500,000.00 FOR REPAIRS, RENOVATIONS AND REPLACEMENTS TO THE PARK, OPEN SPACE AND FACILITIES.

WHEREAS, the City has parks, open spaces, and facilities located throughout the City that require renovation and replacement of play structures and equipment which may include unexpected service repairs and emergency renovations; and

WHEREAS, the services needed must be outsourced to professionals that can safely and efficiently address those needs; and

WHEREAS, the City entered into a piggyback agreement pursuant to Procurement Code 2-945 with Representative Services to provide and install various equipment and amenities for parks, open spaces, and facilities on August 14, 2019, and

WHEREAS, the service contract provides for a comprehensive solution to renovating and replacing various equipment and amenities for parks, open spaces and facilities while providing installation, maintenance, and repair services;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission hereby authorizes an increase in the award amount for contract number RFP 18/19-2 in an initial amount of \$1,500,000.00 and approves the additional spending authority through the remaining term of the agreement in amount not to exceed the available budget.
- **SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
