Ms. Barbara Perez made a motion to excuse today's absence for Mr. Adams. Mr. McGregor seconded the motion, which passed unanimously. There was no discussion regarding the absences.

# 4. Economic Development Activities:

# a) Visitation Program

Mrs. Belkys Perez informed the Board of the City's interest in understanding the needs of the business community. On February 22nd, she met with the Beacon Council and Coral Gables Chamber to discuss the creation of a survey and business visitation program to send out to the businesses. The goal is to keep the survey to only a few questions and target 30 large companies the first year. Depending on the response, the program could expand. Mr. Kohnstamm commended the department for putting together this program. To his knowledge, no municipality in Miami-Dade County has a sustained Economic Development visitation program.

## b) Competitive Assessment Update

Mrs. Belkys Perez updated the Board regarding a recent conversation with Dr. Murray who is finalizing the Economic Development Competitive Assessment before it is presented to the Board at the next meeting on May 3, 2023.

## c) Broker Event

Mrs. Valdes provided the Board with flyers and informed them that tomorrow, March 2nd, the Department will be hosting an event with Miami Commercial spotlighting Coral Gables. The Mayor will be attending. Mrs. Belkys Perez, IT Director Raimundo Rodulfo and Sustainability Specialist Matt Anderson will be presenting on all the things that make Coral Gables special. Guests will hear about new developments and later board a trolley for a tour of our mixed-use residential projects.

## d) Moon Over the Gables

Mrs. Belkys Perez informed the Board that the City has partnered with the Coral Gables Community Foundation to host the public art activation Moon Over the Gables. The project will take place March 9-25, 2023, Thursday through Saturday at Ponce Circle Park. For further information, please visit moonoverthegables.com. Mrs. Snow informed the Board the moon will rise at 5:00 p.m. every night. There are events planned every night. The exhibit has been featured all over the world. Restaurants will be providing special for the month of March.

#### 5. International Affairs

Ms. Leticia Perez informed the Board that on February 22, 2023, St. Lucia celebrated their 44th Anniversary of Independence & Flag Raising Ceremony in the garden at the Merrick House. There was 35-40 people in attendance.

## 7. Open Discussion

Ms. Ramudo mentioned that the paseos and parking garage #1 are in deplorable conditions, rusted, dirty and in need of maintenance.
