RESOLUTION NO. 2024-

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO A COOPERATIVE AGREEMENT WITH THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, FOR PROJECT VICTORY, A PROGRAM THAT ASSISTS YOUNG ADULTS WITH DISABILITIES BY PROVIDING WORK SKILLS AND EMPLOYMENT TRAINING WITHIN THE CITY OF CORAL GABLES.

- **WHEREAS**, Project Victory is a program developed by Miami-Dade County Public Schools ("MDCPS") to prepare students with disabilities for financial, personal/social, and/or independent functioning through the acquisition of employability skills essential for success in the workplace; and
- **WHEREAS**, Project Victory is designed for up to 12 students per semester who are enrolled in a Miami-Dade County public school and are referred to Project Victory by their teachers, program specialists, and other school support staff; and
- **WHEREAS**, the City has hosted Project Victory the last 2 school years and wishes to continue to host Project Victory at City Hall, the 427 Building and the Public Safety Building to allow students to benefit from on-the-job training and real-life experiences; and
- **WHEREAS**, MDCPS will continue to provide an on-site-teacher and paraprofessional job coach that provides instruction, support, and direct supervision to students according to a training plan developed for each student in conjunction with a City representative; and
- **WHEREAS**, while working at the City, the City will offer the students employability skills based on the student's capabilities and experience; and
- **WHEREAS**, the City and MDCPS desire to enter into the Cooperative Agreement attached as Exhibit 1 so that the City can continue to host Project Victory and allow students with disabilities to benefit from on-the-job training in various City departments.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission does hereby authorize the City Manager to enter into the Cooperative Agreement with the School Board of Miami-Dade County, Florida (attached as Exhibit 1) for Project Victory, a program that assists young adults with disabilities by providing

work skills and employment training with the City.
