**RESOLUTION NO. 2025-206**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF GRANT AGREEMENT NO. DMS-24/25-342 WITH THE FLORIDA DEPARTMENT OF MANAGEMENT SERVICES UNDER THE LOCAL GOVERNMENT CYBERSECURITY GRANT PROGRAM, TO PROVIDE THE CITY WITH TWO CYBERSECURITY SOLUTIONS AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT AGREEMENT FOR SAID ASSISTANCE.

**WHEREAS**, the Local Government Cybersecurity Grant Program is a competitive grant initiative that provides local governments with software, services, and solutions designed to enhance their cybersecurity posture, protecting critical infrastructure and data; and

**WHEREAS**, in March 2023, the City submitted an applied to the Local Government Cybersecurity Grant through the Florida Department of Management Services; and

**WHEREAS**, in May 2025, the City received a notice of award under the competitive grant; and

**WHEREAS**, through this grant, the City was awarded two cybersecurity platforms to protect external assets: an external assets discovery and Risk Management solution and an external network traffic acceleration and protection solution; and

**WHEREAS**, these platforms will enhance the existing cyber-protection strategies currently employed by the city to protect external facing assets, thus increasing our ability to minimize and mitigate cyber risks in this area of the environment;

**NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** That the forgoing “**WHEREAS**” clauses are hereby confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption herein.


