RESOLUTION NO. 2009-235

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD SEGOVIA STREET AND BILTMORE WAY ROUNDABOUT PROJECT TO SOLUTION CONSTRUCTION, INC., PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE, ENTITLED "CONTRACT AWARD", INVITATION FOR BID (IFB) 2009.05.08 AND THE COMMUNITY SMALL BUSINESS ENTERPRISE (CSBE), TWENTY PERCENT (20%) SUBCONTRACTOR GOAL REQUIREMENTS, IN THE AMOUNT OF \$310,309.00 (THREE HUNDRED TEN THOUSAND THREE HUNDRED NINE DOLLARS).

WHEREAS, the Segovia Street and Biltmore Way Roundabout Project is part of a joint participation agreement between the City of Coral Gables and Miami-Dade County Small Business Development Office, which requires that the contractor selected for this project will meet the Community Small Business Enterprise (CSBE) Twenty Percent (20%) Subcontractor Goal; and

WHEREAS, on June 5, 2009, the Procurement Division of Finance formally advertised, issued and distributed the Segovia and Biltmore Roundabout Project Invitation to Bid (IFB) 2009.05.08; and

WHEREAS, on June 12, 2009, a non-mandatory pre-bid conference was held and six (6) prospective bidders attended with a total of twenty (20) prospective bidders downloading the bid document or picked up the document from the Procurement Division of Finance; and

WHEREAS, On June 25, 2009, five (5) bid responses were submitted by: Solution Construction, Inc., Florida Engineering and Development, Wrangler Construction, Inc., JVA Engineering, and Williams Paving, Inc., and of those that responded one (1) bid was deemed non-responsive by Miami-Dade County Public Works Department Special Projects Administrator on behalf of Miami-Dade County Small Business Development Office; and

WHEREAS, on July 28, 2009, confirmation was received from the Miami-Dade Public Works Department accepting Solution Construction, Inc., as the lowest responsive, responsible bidder meeting Community Small Business Enterprise (CSBE) Twenty Percent (20%) Goal requirements making it eligible to be awarded a contract for the Segovia Street and Biltmore Way Roundabout; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, pursuant to Procurement Code Section 2-828, entitled "**Contract Award**," contract awards for supplies and services exceeding \$100,000.00 shall be approved by the City Commission, and it is recommended by the Chief Procurement Officer that this Contract Award for Solution Construction, Inc., be approved;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission does hereby direct the City Manager to authorize the Chief Procurement Officer to award the Segovia Street and Biltmore Way Roundabout Project to Solution Construction, Inc. pursuant to Section 2-828, entitled "**Contract Award**," of the Procurement Code Invitation for Bid (IFB) No. 2009.05.08 and the Community Small Business Enterprise (CSBE) Twenty Percent (20%) Subcontractor Goal in the amount of \$310,309.00 (Three Hundred Ten Thousand Three Hundred Nine Dollars)

SECTION 3. That this resolution shall become effective upon the date of its passage and adoption herein.
