RESOLUTION NO. 2010-179

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD TO WILLIAM RIEHL INVESTIGATIONS, INC., THE CONTRACT FOR BACKGROUND INVESTIGATION SERVICES AT A RATE OF \$60.00 PER HOUR, NOT TO EXCEED \$60,000.00 (SIXTY THOUSAND DOLLARS) ANNUALLY, PURSUANT TO IFB 2010.07.02 AND SECTION 2-828 OF THE PROCUREMENT CODE FOR AN INITIAL THREE (3) YEAR TERM WITH TWO (2) ADDITIONAL ONE (1) YEAR RENEWAL OPTIONS.

WHEREAS, On August 5, 2010, the Procurement Division of Finance formally advertised, issued and distributed the Background Investigation Services Invitation for Bid (IFB) 2010.07.02; and

WHEREAS, twenty-seven (27) vendors requested IFB packages from the Procurement Division of Finance and on July 29, 2010, four (4) vendors submitted bids as follows: Investigative Analysis LLC, William Riehl Investigations, Inc., Global Investigations, Inc., d/b/a Global Eye and Jurney & Associates submitting bid responses and one (1) company Inquesta Corporation submitting a no bid; and

WHEREAS, two (2) bidders; Investigative Analysis LLC and Jurney & Associates were determined unqualified, because they did not meet the three (3) year police enforcement background investigations requirement of the IFB; and

WHEREAS, the City Commission does hereby accept the recommendation of the Chief Procurement Officer to award the Background Investigation Services contract to William Riehl Investigations, Inc., at a rate of \$60.00 per hour, not to exceed \$60,000.00 (sixty thousand dollars) annually pursuant to IFB 2010.07.02 and Section 2-828, entitled "*Contract Award*," of the Procurement Code for an initial three (3) year term with two (2) additional one (1) year renewal options; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby accept the recommendation of the Chief Procurement Officer to award the Background Investigation Services contract to William Riehl Investigations, Inc., at a rate of \$60.00 per hour, not to exceed \$60,000.00 (sixty thousand dollars) annually pursuant to IFB 2010.07.02 and Section 2-828, entitled "*Contract Award*," of the Procurement Code for an initial three (3) year term with two (2) additional one (1) year renewal options.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
