RESOLUTION NO. 2009-119

A RESOLUTION ACCEPTING THE CHIEF PROCUREMENT OFFICER'S RECOMMENDATION PURSUANT TO PROCUREMENT CODE SECTION 2-772, ENTITLED "SPECIAL PROCUREMENT/BID WAIVER" TO LEASE FROM PETERSON HARLEY DAVIDSON OF MIAMI, LLC ELEVEN (11) HARLEY DAVIDSON POLICE MOTORCYCLES FOR A TERM OF TWENTY-FOUR (24) MONTHS, WITH THE TOTAL LEASE PAYMENT AMOUNT NOT TO EXCEED \$112,200.00, FOR ALL LEASED MOTORCYCLES. (TO BE FUNDED BY THE AUTOMOTIVE FUND).

WHEREAS, on March 24, 2009 the Procurement Division contacted Peterson Harley Davidson of Miami regarding their interest in renewing the lease of eleven (11) Police Motorcycles for the Police Department; further stating that on April 17, 2009, Peterson Harley Davidson submitted a new lease agreement attached hereto; and

WHEREAS, pursuant to Procurement Code Section 2-772, entitled "*Special Procurement/Bid Waiver*", it is hereby recommended by the Chief Procurement Officer that this lease with Peterson Harley Davidson of Miami, LLC, be granted a bid waiver as a result of their status of being the only local Harley Davidson dealer in the Miami-Dade County for sales and service and their competitive pricing; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations regarding the Procurement Code;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby direct the City Manager to execute a lease agreement for eleven (11) Harley Davidson Police Motorcycles for a term of twenty-four (24) months billed monthly at a rate of \$425.00 per motorcycle monthly not to exceed \$112,000.00 for all leased motorcycles.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
