RESOLUTION NO.

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND CONTRACT NO. RFP 2018-001 FOR DISASTER DEBRIS MONITORING SERVICES WITH TETRA TECH, INC, AND TO APPROVE A RATE ADJUSTMENT TO THE COMPENSATION SCHEDULE PURSUANT TO SECTION 2-764 OF THE CITY'S PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS".

WHEREAS, the City and Professional previously entered into a Professional Services Agreement effective May 23, 2018, ("Agreement"), for Disaster Debris Monitoring Services RFP 2018-001 ("Services"); and

WHEREAS, the Professional requested a two-point seven six percent (2.76%) rate adjustment based on the rise in the Consumer Price Index.

WHEREAS, the adjusted amount is in accordance with the requirements outlined under RFP 2018-001 Exhibit B Compensation Schedule, the City has agreed to the two-point seven six percent (2.76%) rate adjustment that would amend the contract pricing for the identified lines to become effective upon execution of the amendment.

WHEREAS, the current Agreement is set to expire May 22, 2025; and

WHEREAS, the Parties desire to extend the Agreement from May 22, 2025, until November 30, 2025 to coincide with the end of the Hurricane Season.; and

WHEREAS, contract changes are allowable by FEMA as long as documented procurement policies and procedures are followed pursuant to 2 C.F.R § 200.317; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on change orders and contract modifications; and

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to approve the amendment to

Exhibit B Compensation Schedule by two-point seven six percent (2.76%) and to extend contract RFP 2018-001 for Disaster Debris Monitoring Services until November 30, 2025, pursuant to section 2-764 of the procurement code entitled "Approval of Change Orders and Contract Modifications".

Section 3. That this resolution shall become effective upon the date of its adoption herein.
