**PLEASE CLEAN DIRTY ROOF, FACIA BOARD, WALKWAY, AND DRIVEWAY RIBBONS. FRONT PLANTER IN NEED OF MANTINANCE (TRIM BACK PLANTS AND CLEAN PLANTER, TOUCH UP PAINT IF NEEDED), REPAIR FRONT PORCH AREA (PEELING PAINT AND CRACKS VISIBLE) CLEAN ENTRYWAY.**
