AMENDMENT # 2

THIS **SECOND AMENDMENT** TO THE PROFESSIONAL SERVICES AGREEMENT is made as of this 6 day of December, 2024, between the City of Coral Gables (hereinafter called the City"), and Ceres Environmental Services, Inc. (hereinafter called the "Professional").

RECITALS

WHEREAS, the City and Professional previously entered into a Professional Services Agreement effective December 5, 2018, ("Agreement"), for Disaster Debris Removal Services RFP 2018-009C ("Services");
and

WHEREAS, the Parties desire to extend the Agreement from August 20, 2025 until November 30, 2025 to coincide with the end of the Hurricane Season.

WHEREAS, per Section 16.1 Modification, the agreement may not be amended or modified unless in writing and signed by both parties.

NOW, THEREFORE, the Parties agree, understand, accept, and acknowledge that through this Amendment, the Professional Services Agreement for Disaster Debris Removal Services is hereby modified as follows:

1. The City and Professional hereby acknowledge that the extension period shall commence August 21, 2025, and continue until November 30, 2025.
3. All other terms and conditions of the agreement remain unchanged and in effect.

All other terms and provisions of the Agreement are hereby confirmed and shall remain in full force and effect, except as modified herein.

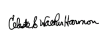

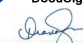

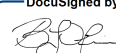
