**RESOLUTION NO. 2012-200**

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER PURSUANT TO SECTION 2-828 ENTITLED "CONTRACT AWARD" OF THE PROCUREMENT CODE AND INVITATION FOR BID (IFB) 2012.09.19 TO AWARD THE PONCE DE LEON BLVD/ALHAMBRA CIRCLE LANDSCAPING AND MISCELLANEOUS IMPROVEMENTS PROJECT TO ABC CONSTRUCTION, INC.; AND AUTHORIZING A BUDGET AMENDMENT TO THE FISCAL YEAR 2012-2013 ANNUAL BUDGET TO RECOGNIZE AS REVENUE A TRANSFER FROM GENERAL FUND RESERVE AND TO APPROPRIATE SUCH FUNDS TO PUT TOWARD THE COST OF THE PROJECT.

**WHEREAS**, on September 19, 2012, the Procurement Division formally advertised, issued, and distributed the Ponce de Leon Blvd/Alhambra Circle Landscaping and Miscellaneous Improvements Project Invitation for Bid (IFB) 2012.09.19; and

**WHEREAS**, on September 26, 2012, a non-mandatory pre-bid conference was held; and

**WHEREAS**, on October 16, 2012, bid responses were received from the following five (5) firms: Sanchez Arango Construction, ABC Construction, Inc., LEE Construction Group, Inc., SFM Services, Inc., and V Engineering & Consulting Corporation; and

**WHEREAS**, the lowest responsive, responsible bid for Ponce de Leon Blvd/Alhambra Circle Landscaping and Miscellaneous Improvements Project was submitted by ABC Construction, Inc., with a total bid of \$533,450, which consists of the base bid of \$529,900 and \$2,250 for Alternate No. 1 for transplanting three (3) existing Medjool palms on other City property, and \$1,300 for Alternate No. 2 for relocating two (2) existing Medjool palms to the center of the median; and

**WHEREAS**, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

**WHEREAS**, the Chief Procurement Officer pursuant to Section 2-828 entitled "Contract Award" of the Procurement Code and Invitation for Bid (IFB) 2012.09.19, recommends that ABC Construction, Inc. be awarded the Ponce de Leon Blvd/Alhambra Circle Landscaping and Miscellaneous Improvements Project; and

**WHEREAS**, C3TS, the consulting engineering firm for the project, and the Public Works Department concur with the recommendation of the Chief Procurement Officer to award ABC Construction, Inc. the Ponce de Leon Blvd/Alhambra Circle Landscaping and Miscellaneous Improvements Project; and

**WHEREAS**, a budget amendment to the Fiscal Year 2012-2013 will be required to recognize as revenue a \$308,450 transfer from General Fund Reserve and to appropriate such funds to put toward the cost of the project;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer pursuant to Section 2-828 entitled “Contract Award” of the Procurement Code and Invitation for Bid (IFB) 2012.09.19 to award the Ponce de Leon Blvd/Alhambra Circle Landscaping and Miscellaneous Improvements Project to ABC Construction, Inc. in the amount of \$533,340, subject to final approval and execution of a contract by City staff.

**SECTION 3.** That the City Commission authorizes a budget amendment to the Fiscal Year 2012-2013 Annual Budget to recognize as revenue a \$308,450 transfer from General Fund Reserve and to appropriate such funds to put toward the cost of the project.

**SECTION 4.** That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

**SECTION 5.** That this Resolution shall become effective upon the date of its adoption herein.

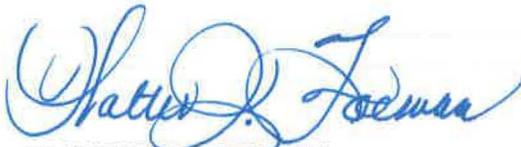
