**Police Update:**

- Sgt Erasmo Lopez advised he had no update. David stated that there was an accident on University and Lejeune at the end of September. Every month he witnesses an accident. Sgt. Lopez advised that they do monitor the intersection however they cannot have a police officer stationary in the intersection, however they do perform citation enforcement.

**New Business**

10 Minute Presentation about Coral Gables school bus options was presented by Debbie. Debbie informed the board of what Jessica Keller met with Gables Prep and Sunset Elementary school principals in an effort to address congestion issues around school zones. Gables prep principal rejected the idea because “Cuban mothers will not put their children on buses”, Sunset elementary stated that everything is fine and there is nothing to optimize. Debbie believes that the new principals will be open to discuss. Discussion ensued about the funding and possible trial period. Debbie suggested for someone to reach out to the schools and revive this initiative. Henry stated that he will reach out to the school principals.
