CASE FILE COA (SP) 2018-004: An application for the issuance of a Special Certificate of Appropriateness for the property at 821 Obispo Avenue, a contributing resource within the "Obispo Avenue Historic District," legally described as Lot 16, Block 28, Coral Gables Section "B," as recorded in Plat Book 5, at Page 111, of the Public Records of Miami-Dade County, Florida.
