<u>F.</u><u>NOTE</u>

Any person making impertinent or slanderous remarks or who become boisterous while addressing the Committee, shall be barred from further audience before the Committee by the Chair, unless permission to continue or again address the Committee is granted by the majority vote of the Members present. Any meeting may be opened and continued and, under certain circumstances, additional legal notice will not be provided.
