## **RESOLUTION NO. 2022-16**

RESOLUTION OF THE CITY **COMMISSION** Α AUTHORIZING DEVELOPMENT OF A PUBLIC ART PROJECT OF ARTISTICALLY DESIGNED STOREFRONT WINDOW COVERINGS FOR USE BY BUSINESSES WITHIN CORAL GABLES IN PARTNERSHIP WITH THE BUSINESS IMPROVEMENT DISTRICT; ALLOWING FOR STAFF TO DRAFT AND EXECUTE A CALL FOR ARTISTS TO DEVELOP PROPOSED DESIGNS; AND ALLOWING USE OF ART IN PUBLIC PLACES FUNDS UP TO TEN THOUSAND DOLLARS (\$10,000) TOWARD ARTIST FEES ASSOCIATED WITH THE PROJECT. (UNANIMOUSLY RECOMMENDED BYTHE CULTURAL DEVELOPMENT **BOARD** APPROVAL/DENIAL VOTE: 6 TO 0).

**WHEREAS,** it is understood that there may be moments when a business is unoccupied, leaving windows bare, with views into undeveloped interiors; and

**WHEREAS**, the Historical Resources & Cultural Arts department, in partnership with the Economic Development department and Business Improvement District, wish to develop a program that contributes to the beautification and welcoming atmosphere of the Downtown area; and

**WHEREAS**, the proposed program will invite area artists and designers to submit qualifications for consideration to develop customized window coverings that also function as public art, and opportunities for social engagement; and

**WHEREAS**, the program is intended as a pilot program of the arts and business community. If successful, the program may expand to include a greater geographic area and more artists; and

WHEREAS, the Cultural Development Board met and recommends the program; and

**WHEREAS**, funds for the project up to \$10,000 are proposed through use of the art acquisition fund;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES AS FOLLOWS:

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby authorize staff to move forward with developing and executing a public art project of artistically designed storefront window coverings; allowing for \$10,000 from the Art Acquisition Fund to cover the pilot program.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
