## **RESOLUTION NO. 2022-04**

A RESOLUTION OF THE CITY COMMISSION APPROVING ENTERING INTO AN AGREEMENT WITH ADWAVE SIGNS TO DESIGN, FABRICATE, AND INSTALL SIGNAGE FOR PUBLIC ARTWORKS THROUGHOUT THE CITY; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2021-2022 ADOPTED BUDGET TO TRANSFER UP TO \$80,000 FROM THE ART IN PUBLIC PLACES FUND BALANCE AND APPROPRIATING SUCH FUNDS TO COVER CONTRACT FEES AND REIMBURSABLE EXPENSES.

**WHEREAS,** public artwork in the City's collection requires uniform signage that is ADA compliant; and

**WHEREAS,** it is in the best interest of the City to have on-site signage at the artworks that is in English and Spanish, includes braille, and facilitates access to additional information; and

**WHEREAS,** a Request for Proposals (RFP) was published and announced on the City's website for the design, fabrication, and installation of signage for the City's public art collection; and

**WHEREAS**, following an extension of the RFP, one sign professional was responsive and submitted initial design concepts that complied with the RFP; and

**WHEREAS**, funding for the public art signage with Adwave Signs is estimated to be \$70,500 and is being proposed through the art acquisition fund with reimbursable expenses anticipated; and

**WHEREAS**, amendment to the Adopted Fiscal Year 2021-2022 Budget is required to transfer \$80,000 from the Art in Public Places fund balance and appropriate such funds to put toward this project;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby authorize entering into an agreement with Adwave Signs for the design, fabrication, and installation of public artwork signs.

**SECTION 3.** That the Commission does hereby authorize an amendment to the Adopted Fiscal Year 2021-2022 Budget to transfer \$80,000 from Art in Public Places fund balance; and appropriate such funds to put toward the project.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
