## **RESOLUTION NO. 2022-217**

A RESOLUTION WITH ATTACHMENTS, OFFICIALLY ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF RESULTS FROM THE CITY OF CORAL GABLES BUSINESS IMPROVEMENT DISTRICT (BID) PETITION ELECTION OF MAY 1<sup>ST</sup> THROUGH JUNE 30<sup>TH</sup>, 2022.

## BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the results of the Business Improvement District (BID) Petition Election, as hereinafter set forth, are hereby accepted.

The results of the Coral Gables Business Improvement District (BID) Petition Election, which was conducted by a petition process of 178 affected property owners, which was completed on June 30, 2022, were as follows:

- 80 Properties submitted in support For Continued Existence of BID.
- 87 Properties failing to file a petition
- 11 Properties submitted in support rejected by City Clerk

Total: 178

Note: The vote count was as follows: 91 (51.12%) votes were cast by property owners within the Business Improvement District for the continued existence of the BID, and no petitions were received for 87 properties, which is tabulated as a vote against the continued existence of the BID (48.88%). Finally, there 11 votes (on 8 petitions filed) which were rejected for issues with the notarization, and/or failure to meet the established signature verification/authorization criteria.

Therefore, the petition process did not obtain the necessary approval of a majority of affected property owners for the continued existence of the BID.

**SECTION 2.** That the City Commission does hereby accept the City Clerk's Certification and Declaration of Results from the aforementioned BID Election (May 1<sup>st</sup> through June 30<sup>th</sup>, 2022).

**SECTION 3.** That said Resolution shall become effective upon the date of its passage and adoption herein.
