Good afternoon Ms. Shute. There currently is an off-leash dog park open to the public that is suitable for large dogs. It is at Barker Park on Venetia. I did not mention that during the meeting because the last thing us dog owners want is another neighborhood dog park closed off to dogs being able to play off-leash due to their neighborhood being over-run by people driving to the park.

In case you did not hear, I have pressed long and hard for off leash dog parks to be added to our City. Like you, I have not one, but two dogs, that need to run. They are retired greyhounds. And, like you, I used to visit Catalonia Park when staff failed to add the signage that made it clear that it was not an off-leash park.

Once the park and the neighborhood became overrun by individuals tearing up swales and not picking up after their dogs, the residents living near Catalonia Park complained loudly. I have received many emails and visits from these very vocal neighbors. In respect for what was their choice for a children's park, I have respected their choice and have taken my dogs elsewhere. Keep in mind that I live three blocks away. Catalonia was a wonderful place to connect with dog owning neighbors and watch our four legged furry family members play.

In my quest to find suitable space for a dedicated off-leash dog park where there will be no conflicts between small children and dogs, I looked in the North Gables for existing park space and empty lots. I first tried the large fields near the Youth Center, but the neighbors strongly resisted, even though I offered many concessions to address their concerns. I next tried several empty lots, all of which were privately owned with the owner not interested in selling. I also tried existing park space. After requesting staff to measure the area at Salvadore where the new park will be built, and tiring of waiting, I measured it myself to get the ball moving. I then approached a developer to allow their property at 1505 Ponce to be used as a dog park until the construction begins. That has borne fruit and should be open for the public in 30-45 days.

Your request has not fallen on deaf ears. But out of respect for the wishes of the neighbors living near and adjacent to Catalonia Park who long to have a dog waste free park for their children to play in, I must yield to their wishes. It is their neighborhood and they made it clear what their wishes were long before I ran for office. I cannot ignore these residents and push my preferences upon them.

Lastly, with regard to the proposal the Commission has offered in the interim, it would be a playpen for large dogs like the Villa Valencia park is for them. Please go check out Barker Park in the interim. Please do not spread the information far and wide about this park, because the last things dogs owners would like is for residents nearby to complain.
