RESOLUTION NO. 2022-243

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING SATCHMO BLUES BAR AND GRILL, INC. D/B/A FRITZ & FRANZ BIERHAUS TO UTILIZE THE PUBLIC SPACE AND SELL ALCOHOLIC BEVERAGES, SUBJECT TO APPLICABLE STATE LAW REQUIREMENTS, AT THE PLAZA LOCATED AT 60 MERRICK WAY FROM 10:00 A.M. TO 6:00 P.M. ON TWENTY-TWO DAYS FROM SUNDAY, NOVEMBER 20, 2022, THROUGH SUNDAY, DECEMBER 18, 2022, DURING THE 2022 FIFA WORLD CUP CELEBRATION.

WHEREAS, the 2022 FIFA World Cup (the "World Cup") will take place from November 20, 2022 through December 18, 2022 and the City's Special Events Committee reviewed a request by Satchmo Blues Bar and Grill, Inc. d/b/a Fritz & Franz Bierhaus (the "Applicant"), requesting permission to have viewing parties and sales of food and alcohol on the plaza located at 60 Merrick Way, for various of the soccer matches being televised during the World Cup schedule; and

WHEREAS, the Special Events guidelines limit the number of event days per year for locations adjacent to residential properties to a maximum of twenty-four (24) event days per year and the Applicant requests to keep the plaza set-up throughout the duration of the World Cup, which exceeds twenty-four (24) days, but the Applicant acknowledges and accepts that the "special event" can only occur during the twenty-two days on which twenty-two selected matches will be televised (as indicated in Applicant's Special Events application) ("Special Event Matches"), subject to certain conditions; and

WHEREAS, the Applicant agrees and accepts that it will not hold an Oktoberfest season event in 2022;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. That Applicant's special event permit to utilize the public plaza located at 60 Merrick Way is hereby granted with the following conditions:

- a. With the exception of the Germany Japan soccer match on Wednesday, November 23, 2022, there will be no televising of any games on the plaza before 10:00 am.
- b. Sales of alcohol and food will only be permitted on days when the Special Event matches are televised (22 total days).

- c. For games not specified as Special Event Matches, only the basic sound from the base speakers will be allowed. Amplified sound from remote speakers is prohibited for all non-special event matches.
- d. Applicant will not allow customers or participants to have instruments on the plaza at any time, regardless of whether it is a day during which a Special Event Match is being televised.
- e. Off-Duty police will be hired by the Applicant for games anticipated to have high attendance, as determined by City staff.
- f. Applicant understands that failure to follow any of the conditions set will result in Police terminating the daily activity and could result in revocation of the entire permit.

SECTION 3. Permission is hereby granted for Applicant to sell alcoholic beverages from 10:00 A.M. to 6:00 P.M. on the twenty-two days November 20, 2022 and December 18, 2022 when Special Event Matches are televised, subject to all State of Florida requirements.

SECTION 4. The Applicant has agreed not to hold an Oktoberfest season event in 2022.

SECTION 5. That this Resolution shall become effective upon the date of its passage and adoption herein.
