Property Advisory Board Chair Mr. Jack Lowell brought the meeting to order at 8:45 a.m.

1. Review and approval of September 14, 2022, Property Advisory Board Meeting Minutes. Mr. Niebla made a motion to approve the meeting minutes and Ms. Dunaj seconded the motion, which passed unanimously. There was no discussion regarding the minutes.

2. Election of Chair

Mr. Niebla made a motion to elect Mr. Jack Lowell for the position as Chair. Ms. Dunaj seconded the motion, which passed unanimously. Mr. Lowell accepted the nomination.

Ms. Dunaj made a motion to elect Mr. Manuel Niebla as Vice-Chair. Mr. Lowell seconded the motion, which passed unanimously. Mr. Niebla accepted the nomination.

3. Coral Gables Museum Presentation

Mr. Fuentes provided the Board with the same presentation that was provided at the Annual Members' Meeting on the last day of the fiscal year on September 30, 2022. Mr. Fuentes was appointed as Executive Director in March of 2022. They have added three new board members to add more expertise

in terms of museum work. They're in the process of accrediting the museum with the American Association of Museums which will take several years to complete.

Since the commencement of the fiscal year on October 1, 2022, they've had 59,244 visitors. Most of the visitors are through free events and programs such as Family Day, which is the second Saturday of the month, and Gallery Night, which is the first Friday of the month. They're looking to add other events.

Mr. Fuentes presentation was followed by a questions-and-answers session.

• Rent Report

Ms. Sardiñas provided the Board with a copy of the Rent Report and informed the Board that there were no issues with the rent report.

Ms. Anderhub had several questions regarding the Rent Report which Ms. Sardiñas addressed.

Mr. Niebla requested that a summary of the renewal terms be provided to the Board. (Ex. Commencement date, term date, options). Ms. Sardinas suggested adding a column to the rent report that includes each Lease Agreement's renewal terms.

• Unsolicited Bid - Unsolicited Bids- 477 South Dixie Highway, Coral Gables, FL 33146

Ms. Sardiñas informed the Board that the City received an unsolicited bid inquiry a lease renewal for the property located at 477 South Dixie Highway. A copy of the unsolicited email received was provided to the Board. A response was provided to the inquiry stating that the City can provide a lease extension for the 477 S. Dixie Highway city-owned surface parking lot, as long as the lease agreement includes a reasonable termination for convenience clause and appropriate compensation for the use of same.

• Update on the 278 Miracle Mile Lease Commission Ordinance

Ms. Sardiñas informed the Board that the Lease Ordinance went through City Commission and passed. She will be invoicing them for the deposit, and they're getting their insurances in place to commence their investment and buildout.
