You, as the owner of the premises at:

2700 PONCE DE LEON BLVD, Coral Gables, FL 33134-6005

are in violation of the following sections and subject to Section 101-107 of the City Code of the City of Coral Gables by:

**Uncompleted Building - Section 14-202.7. Zoning permit.** 

D. Incomplete buildings. No building not fully completed in substantial compliance with plans and specifications upon which a building permit was issued shall be permitted to be maintained on any land for more than one (1) year after the commencement of erection of any building, addition or renovation. A building site inspection shall be conducted six (6) months after the commencement of construction at which time evidence that work is proceeding shall be provided by the contractor. Work shall be considered to have commenced and be in active progress when, in the opinion of the Building and Zoning Director, a full complement of workmen and equipment is present at the site to diligently incorporate materials and equipment into the structure throughout the day on each full working day, weather permitting. This provision shall not be applicable in case of civil commotion or strike or when the building work is halted due to an injunction or other court order.

Code Enforcement Officer Comments: At time this case was opened, the building process had not commenced and there had been no permit inspections in over 6 months. Permit was expired.

The following steps should be taken to correct the violation:

Comply with Section 14-202.7(D) - extended permit has expired/building has not commenced and had no inspections in over 6 months. Must renew permit and complete building and inspection process.

As a result of the above violation(s), a complaint has been filed against you and you are hereby commanded to appear before the Code Enforcement Board for a hearing on <u>5/17/2023</u> at 8:30 am in the Commission Chambers, located on the second floor of:

City Hall 405 Biltmore Way Coral Gables, Florida 33134

The hearing shall be on the Respondent's request, dated March 30, 2023, to extend the deadline for compliance of April 2, 2023 ("Request"), in the Code Enforcement Board Enforcement Order, dated October

19, 2022 ("Order"). The hearing shall be strictly limited to considering the Request. Any applicable fines shall continue to accrue while the hearing is pending and, if you are not successful at the hearing, fines will have accrued retroactive to the deadline in the Order. You may also be liable for the reasonable costs of the administrative hearing.

This is your notice to appear at said time and place. Failure to do so will result in the matter being heard in absentia. An administrative fee of \$108.75 will be assessed at the time of your hearing.

Please be advised that if someone will be attending the hearing on your behalf, he or she must provide a power of attorney from you at the time of the hearing.

If this notice pertains to failure to maintain a historic structure, please be advised that:

- You may be subject to substantial fines that may not be mitigated.
- You may also be required to repair or restore the historic structure.
- If the historic structure is allowed to deteriorate to the point where it must be demolished:
  - the City Code requires that you replace the structure with a similar historicallyappropriate structure; and
  - the property will no longer qualify for an historic preservation tax exemption.

- Usted puede recibir multas muy grandes que tal vez no pueden ser aminoradas.
- Es posible que también deba reparar o restaurar la estructura histórica.
- Si se permite que la estructura histórica se deteriore hasta el punto en que debe ser demolida:
  - o El Código de la Ciudad requiere el reemplazo de la estructura con una similar que sea apropiadamente histórica; y
  - La propiedad ya no será elegible para una exención de impuestos por preservación histórica.
