2. Presentation by Thad W. Adams, Senior Vice President of the Allen Morris Company

Mr. Adams made a power-point presentation updating the Coral Gables office and retail real leasing market. The update showed a general drop in local office vacancy rates, with vacancies in the Class A office spaces dropping from 26 to 20 percent. Mr. Adams said that Brickell, which has "huge chunks of space" that offer "big discounts," and the area around Miami International, which offers abundant parking, are major competitors. He said the retail leasing market faces competition from Brickell and Miami Beach. Mr. Adams said that businesses often locate near the homes of their decision makers.

3. Review Outstanding Rent Report

The Board reviewed the Outstanding Rent Report which showed tenants to be current. Mr. Roberts updated the board on current negotiations.

4. Additional Business.

The board discussed the Palace, replacement of Downtown public parking structure and the Streetscape Project. Ms. Birdsill informed the board of the upcoming "Water Is Life" exhibit."

A motion to close the meeting at 9:22 a.m. passed unanimously.
