January 27, 2011- Special City Commission Meeting on Miracle Mile and Giralda Streetscape

John O'Rourke Chairman of Coral Gables Chamber of Commerce and co-owner of Montica Jewlery:

Mari Gallet-Executive Director of the BID: Good morning. Thank you Commissioners, City Manager. You couldn't see me, but I was doing a little dance back there during Richard's presentation. For those of you, and I don't think there's that many because we have a lot of stakeholders here today, I want to just let you know that the BID-the Business Improvement District is an organization that's been created through a special assessment which includes all of Miracle Mile, Giralda's restaurant row, and all commercial properties between Giralda and Andalucia, and obviously between Lejeune and Douglas Rd. Our mission is to promote commercial vitality to Miracle Mile and downtown Coral Gables and to act as a strategic catalyst for the overall improvement of the area.

I'd like to first thank Rickard Heapes from Streetworks, for his informative and enlightening presentation. When the BID first began our efforts to redevelop our downtown, we only dreamed of something this big, and now Richard has shown us it can become a reality. We are humbled by the affirmation of our work. I'd also like to thank you, the Commission, and the Manager's Office, for dedicating a whole morning in this special meeting for such an important topic to our City and to all

these residents and business owners who are here today supporting the project. In chronological order I have to mention a few folks who are very important and have contributed to this along the way, obviously our BID members, our BID board, our Executive Board all of who are here today, who having so much at stake, have tirelessly been dedicated to this improvement. Our colleagues at the CG Chamber of Commerce who understand the value to our business community and have made this one of their top goals. And if you all saw in Richard's presentation, this great little red brochure, we did work on in about 2008 there's a list of people that I would be remiss not to mention that are on here. These were all volunteers; professionals in our community who live close by and want to be in our downtown. Our committee was comprised of professional engineers, architects, and retail experts and moderated by the University of Miami and their own Jaime Correa and Chuck Bold, both are experts in urban planning. It included David Plummer, Glenn Pratt, John Fullerton, George Hernandez, Carey Newman, and downtown BID members John O'Rourke, from Montica Jewelry, who you heard from today, and Martin Lynch, from John Martins restaurant. And on the ground of course doing so much of the work C3TS.

Most importantly as direct stakeholders in this project, I want you to know that our BID Board just again this week passed a resolution affirming all of the elements as they were presented today, from the parallel parking option that will allow us to make all these exciting upgrades to the equal split between the City and benefitting properties for the future financing of this project. We stand together with you to proceed. And finally to our Commission, Manager and City Staff here today, we share your enthusiasm and vested interest in making our downtown a world class destination from our Public Service Department who are out there every day cleaning Miracle Mile to our Police, our Fire, our Parking Dept., Code Enforcement and many other supporting employees at the City, not only will we all share and cultivate this heart of the Gables, this third space with you, elbow to elbow, day to day, but our success as a community will be tied to it for generations to come.
