DRAFT RESOLUTION _____

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AUTHORIZE A “PIGGYBACK” CONTRACT WITH GENUINE PARTS COMPANY D/B/A NAPA AUTO PARTS FROM THE NATIONAL JOINT POWERS ALLIANCE (NJPA) TO PROVIDE ON-SITE VEHICLE AND EQUIPMENT PARTS AND SUPPLY SERVICES PURSUANT TO SECTION 2-980 OF THE PROCUREMENT CODE FOR A PERIOD RUNNING THROUGH APRIL, 12, 2016, WITH AN OPTION TO RENEW FOR ONE (1) ADDITIONAL YEAR.

WHEREAS, the City’s current on-site vehicle and equipment parts and supply services contract with Genuine Parts Company d/b/a NAPA Auto Parts will expire December 22, 2014, which is a piggyback contract based on a NAPA contract with the City of Miramar, FL; and

WHEREAS, to replace this contract, Procurement is recommending participation in a cooperative purchasing agreement through the National Joint Powers Alliance (NJPA) under Section 2-980 of the Procurement Code; and

WHEREAS, NJPA is a public purchasing cooperative set-up by the State of Minnesota with over 50,000 member agencies nationwide, which the City of Coral Gables is also a member; and

WHEREAS, the NJPA contract with NAPA was competitively solicited by the National Joint Power Alliance under RFP No. 031212, which complies with the solicitation requirements contained with Section 2-978 of the Procurement Code; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission does hereby accept the recommendation of the Chief Procurement Officer to authorize a “Piggyback” contract with Genuine Parts Company d/b/a NAPA Auto Parts from the National Joint Powers Alliance (NJPA) to provide on-site vehicle and equipment parts and supply services pursuant to Section 2-980 of the Procurement Code for a

period running through April, 12, 2016, with an option to renew for one (1) additional year, subject to final approval and execution of a contract by City staff.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
