Motion Summary:

A motion to accept the allocations and scoring for the grants made by the Board during its Grants Funding workshop was passed unanimously.

A motion to approve the minutes from the October 22, 2014 meeting was passed unanimously.

A motion to add a line on the grants scoring sheet for the signatures of board members who recuse themselves passed unanimously.

Ms. Daly called the meeting to order at 10:30 a.m.

1. Grant Application Scoring

Mr. Litwer asked for an explanation of the relationship between the score given to a grant applicant and the money allocated. He noted that some applicants with similar scores were allocated the same amount of funding, even though they were in categories with a different maximum cap for the grant amount. Ms. Daly said that if funds were allocated based on the cap, all applicants would ask for the maximum amount.

Ms. Cole made a motion that grant money for the Greater Miami Youth Symphony be used only for areas funded by the grants. Ms. Markowitz seconded the motion, which passed unanimously.

Ms. Cole made a motion to accept the allocations and scoring made by the Board during the Grants Funding Workshop. Ms. Mayorga seconded the motion, which passed unanimously.

2. Review of Minutes from October 22, 2014

Ms. Cole made a motion to approve the minutes from the October 22, 2014 meeting. Ms. Mayorga seconded the motion, which passed unanimously.

3. Additional Board Business

Ms. Markowitz suggested adding a line on the grants scoring sheet for the signatures of board members who recuse themselves from voting on a grant application. A suggestion was also made to add the grant identification number to the scoring sheet to make it easier to keep track during the scoring process. Ms. Daly agreed that the grants application needed tweaking and suggested that Board members submit their recommendation for any adjustments or changes.

Ms. Markowitz made a motion to add a line on the grants scoring sheet for the signatures of board members who recuse themselves. Ms. Cole seconded the motion, which passed unanimously.

There being no further business to come before the Board, the meeting was adjourned at 10:43 a.m.
