RESOLUTION NO. 2014-269

A RESOLUTION WITH ATTACHMENT, ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF RESULTS, THEREBY CONFIRMING THE RE-ELECTION OF TROY EASLEY WHO RAN UNOPPOSED, AS A MEMBER OF THE CITY OF CORAL GABLES RETIREMENT BOARD (PARTICIPATING FIRE FIGHTER REPRESENTATIVE), FOR A TERM BEGINNING JANUARY 1, 2015 THROUGH DECEMBER 31, 2016, AND ALSO CONFIRMING THE RE-ELECTION OF DONALD "RUSTY" HILL WHO ALSO RAN UNOPPOSED, AS A MEMBER OF THE CITY OF CORAL GABLES RETIREMENT BOARD (PARTICIPATING REGULAR FULL-TIME EMPLOYEE REPRESENTATIVE, TEAMSTERS LOCAL 769), FOR A TERM BEGINNING JANUARY 1, 2015 THROUGH DECEMBER 31, 2016.

WHEREAS, on November 4, 2014, Signature Verification and Nominating Petitions were distributed to each department/division, within the City of Coral Gables to nominate a candidate for the Participating Fire Fighter seat and Participating General Employee seat; and

WHEREAS, on November 6, 2014, Signature Verification forms along with employees paychecks were distributed to those individuals eligible to participate in nominating a candidate for the Participating Fire Fighter seat and Participating General employee seat; and

WHEREAS, as of the November 25, 2014, 5:00 p.m., deadline for submittal of Nominating Petition forms for candidates to the Coral Gables Retirement Board, only Troy Easley received a nomination for the Participating Firefighter seat, thereby running unopposed; and only "Donald "Rusty" Hill received a nomination for Participating General Employee seat, also running unopposed;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby accept the City Clerk's Certification and Declaration of Results, thereby confirming the re-election of Troy Easley resulting from his running unopposed, to serve as a member of the Coral Gables Retirement Board (Participating Firefighter Representative Seat), for a term beginning January 1, 2015 through December 31, 2016.

SECTION 3. That the City Commission does hereby accept the City Clerk's Certification and Declaration of Results, thereby confirming the re-election of Donald "Rusty" Hill resulting from his running unopposed, to serve as a member of the Coral Gables Retirement Board (Participating General Employee Seat), for a term beginning January 1, 2015 through December 31, 2016

SECTION 4. That this Resolution shall become effective upon its passage and adoption herein.
