Mayor Cason: H-2 – City Attorney.

City Attorney Leen: Thank you Mr. Mayor. One moment. Item H-2 – the reason I was taking a moment is there has been a protest filed as to this item, but let me read it into the record first. Item H-2 is A Resolution accepting the recommendation of the Public Works Director to authorize contract negotiations with State Contracting and Engineering Corporation (SCEC), and if necessary, with the other shot-listed firm, as the Construction Manager at Risk for the Miracle Mile and Giralda Avenue Streetscape project pursuant to Section 2-1089 of the City of Coral

Gables Code of Ordinances and Request for Qualifications (RFQ) 2015.12.05. Mr. Mayor this

morning the City received a written protest and a filing fee of \$2,500, which is the standard filing fee from Rickman, which is one of the entities that bid on this project that submitted a proposal.

So what that does under our Code and that's under section 2-950(h), that automatically stays the

procurement, so I know that there is a representative here, I believe from Rickman, I'm not sure

if there is from SCEC. You are welcome to hear from them briefly, but you should not resolve

the protest today because under our Code what will happen is our Chief Procurement Officer has

ten (10) days in which to prepare a report to the City Manager in conjunction with the City

Attorney, which will make his recommendation to the City Manager, and the City Manager will

review it and then make her recommendation to you as to how to resolve the protest. She also

has some authorities on her own to resolve the protest, so all that should occur before it comes

back to you, and then you make the final decision as to whether how to proceed with the

procurement. So with that I would turn it back to the Mayor. Mr. Mayor.

Mayor Cason: OK. So do we need to make any kind of a resolution? Does Rickman want to say

anything now or do you want to wait and make the presentation when this is back to us?

Commissioner Quesada: Yes, it's note ripe for discussion right now.

City Attorney Leen: No. I was told that you might want to say a few words. They can resolve

any of the issues you raised in your protest.

Commissioner Lago: Let's wait.

Mayor Cason: Let's wait. I think on both sides when it comes back to us so we can hear. Thank

you for getting up and down, we appreciate it. So I think that – I guess the correct term is

deferred.

City Attorney Leen: It's automatically stayed by operation of the Code, so in my opinion it

doesn't require a motion. I know that the Clerk as a parliamentary matter, if it's OK with the

Commission will probably want a unanimous consent vote or vote staying the matter until...

Mayor Cason: We all agree?

Commissioner Quesada: I move to stay.

Commissioner Lago: I move to stay also.
