A Resolution accepting the recommendation of the Chief Procurement Officer to authorize contract negotiations with AECOM Technical Services, Inc., as the professional services consultant to conduct a comprehensive fifteen year Community Recreation Master Plan, pursuant to Florida Statute 287.055, known as the "Consultants Competitive Negotiation Act," and Request for Qualifications (RFQ) 2015.09.24.

Mayor Cason: Mr. Pounds.

Mr. Pounds: Mike Pounds, Chief Procurement Officer. The purpose of this RFQ is to select a qualified professional services consulting firm to conduct a comprehensive five-year Community Recreation Master Plan for the City, with it being broken up into five year increments. The Community Recreation Plans for the City that provides an optimal delivery system for park and

recreation services and defines present and future recreation needs for the community. On

October 15, 2015, three qualification statements were submitted in response to the RFQ by

AECOM Technical Services, Green Play LLC, and Sam County Studios. On October 22, 2015,

the evaluation committee convened to conduct an evaluation of the qualification statements to

hear presentations and to conduct interviews. After the presentations and interviews, the

evaluation committee scored and ranked the firms based on the criteria outlined in the RFQ. The

community unanimously ranked AECOM Technical Services, Inc. as the top ranked firm, Green

Play LLC as the second ranked firm, and Sam County Studios as the third ranked firm. The

committee consisted; the evaluation committee consisted of Matt Anderson, Sustainability

Specialist, Fred Couceyro, Parks and Recreation Director, Brook Dannemiller, Public Services

Director, Lauren Matthews, the Parks and Recreation Director for the City of Pinecrest, and

Robert Ruano, Parks and Recreation Advisory Board Member. The top ranked firm is deemed to

be the most highly qualified to perform the required services, will be invited to enter into the

negotiation phase to determine their compensation, that will be paid under contract with the City.

After the compensation has been negotiated, we will be bringing back a contract for your

consideration for approval.

Mayor Cason: So basically we are just authorizing you to start negotiations.

Mr. Pounds: You are authorizing us to conduct negotiations with the first firm and if we are not

able to come to an agreement then we would go to the second firm.
