

ITEM TITLE:

Ordinance on First Reading. Zoning Code Text Amendment. An Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables Official Zoning Code, by amending Appendix A, "Site Specific Zoning Regulations," Section A-36, "Crafts Section," by removing provisions restricting height for the property legally described as Lots 18-21, Block 36, Crafts Section (311 and 315 Santander Avenue), Coral Gables, Florida; providing for codification, and providing for an effective date.

The Planning and Zoning Board at their 12.09.15 meeting recommended approval (vote: 6-0).

BRIEF HISTORY:

At their 12.09.15 meeting, the Planning and Zoning Board recommended approval of the proposed Zoning Code text amendment (vote: 6-0). The proposed amendment is provided in the draft Ordinance in strikethrough/underline format attached as Exhibit A. The 12.09.15 Staff report and recommendation and the excerpts from the 12.09.15 Planning and Zoning Board meeting minutes are provided as Exhibits B and C.

The effect of this text amendment will allow construction of two duplexes on this property that meet the development standards of the Multi-Family 1 (MF1) zoning district, rather than duplexes modified by the Site Specific regulations of one-story maximum building height.
