RESOLUTION NO. 2015-300

A RESOLUTION CONFIRMING THE RE-ELECTION OF JOSHUA NUNEZ WHO RAN UNOPPOSED, AS A MEMBER OF THE CITY OF CORAL GABLES RETIREMENT BOARD (PARTICIPATING POLICE OFFICER REPRESENTATIVE SEAT), AND RE-ELECTION OF RANDY HOFF (AT-LARGE PARTICIPATING EMPLOYEE REPRESENTATIVE SEAT) FOR A TERM WHICH BEGINS ON JANUARY 1, 2016 AND CONTINUES THROUGH DECEMBER 31, 2017.

WHEREAS, on October 22, 2015 Nominating Petitions and Signature Verification forms were distributed to all Coral Gables employees eligible to participate in the Retirement Board Election for the Participating Police Officer and At-Large Employee Representative seats; and

WHEREAS, as of the November 13, 2015, 5:00 p.m., the deadline for submittal of Nominating Petition and Signature Verification forms for candidates to the Coral Gables Retirement Board, only Joshua Nunez received a nomination for the Participating Police Officer seat, thereby winning unopposed; and only Randy Hoff received a nomination for the Participating (At-Large) Employee seat; thereby winning unopposed;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby confirm the election of Joshua Nunez (Participating Police Officer Representative Seat), and Randy Hoff (Participating (At-Large) Employee Representative Seat), to serve as members of the Coral Gables Retirement Board, both seats to serve for a term which will begin on January 1, 2015 and continues through December 31, 2017.

SECTION 3. That this Resolution shall become effective upon its passage and adoption herein.
