A Resolution accepting the recommendation of the Chief Procurement Officer authorizing a Piggyback Contract in accordance with Section 2-978, Use of Other Governmental Unit Contract ("piggyback"), with DODEC, Inc. from the City of Miami Gardens Professional Contractors, pursuant to unit pricing to provide construction and maintenance repair services for timely repairs and improvements to City facilities for a period running until July 31, 2017, under a job order contract.

Mayor Cason: We are going to do H-2 now.

City Manager Swanson-Rivenbark: Mr. Mayor, as Mike Pounds comes forward; we can also postpone some of these items in order to....

Mayor Cason: Put some toward the end, but I think we'll get the critical ones through and then we'll....

City Manager Swanson-Rivenbark: Absolutely. This is an easy one though.

Mr. Pounds: My name is Mike Pounds, Chief Procurement Officer. The City has a need to hire a general contractor to provide timely repairs and improvements to City facilities. This piggyback will allow us to expedite some of those repairs and improvements. The piggyback is from the City of Miami Gardens. We have previously used this piggyback under another contract; this would create a new contract. This new contract would allow for construction, rather than just maintenance and repairs and would allow for projects up to whatever the budgeted amount is. It would not limit it to any certain threshold as in the previous contract. You'll be glad to know that this contractor has done a couple of projects for us, and I think have completed them successfully. They have good EM rating; they have no record of litigation in the last five years; Procurement recommends this firm, and again this will give us an opportunity to do some projects in a more timely fashion than having to wait for a bid or RFP.
