To whom it might concern:

The Cuban Classical Ballet of Miami (CCBM) in collaboration with the Coral Gables Music Club (CGMC), performed on May 17 at the Coral Gables Congregational Church the "End of the Year Musicale 2016" Featuring Cuban pianist Jorge Emilio Rodriguez and soloists from the Cuban Classical Ballet of Miami.

The program included: "Russian Poems" by Edgar Artimiev, "Two Etudes Op. 8" by Alexander Scriabin, "La Muerte del Angel" by Piazzolla, among others, Publicity for the event included: one thousand flyers were printed and distributed, two CCBM posters, 2 radio interviews, and email blast to both organizations e-mail lists.

Around 60 people participated in this event

Grant funds were used to cover artistic fees, printing, graphic design and costumes, copies of checks and detailed grant expenditure were attached to the final report. From the \$2500 total grant award, \$1848 were spent on this performance.

The original grant application included 2 different performances, CCBM has planed and additional performance at the same location on October 18, once again in collaboration with the CGMC.
