

ITEM TITLE:

Ordinance on Second Reading. Zoning Code Text Amendment. An Ordinance of the City Commission of Coral Gables, Florida providing for text amendments to the City of Coral Gables Official Zoning Code, Article 3, "Development Review," Division 11, "Historic Preservation: Designations and Certificates of Appropriateness;" Article 5, "Development Standards," Division 24, "Walls and fences;" and, Article 8, "Definitions" amending criteria for designating historic landmarks and districts, clarifying wood fence requirements, and adding a definition for historic integrity; providing for repealer provision, severability clause, codification, and providing for an effective date.

BRIEF HISTORY:

On September 13, 2016 the City Commission approved the Zoning Code text amendment (vote: 4-0) on first reading. The Zoning Code text amendment is provided in the draft Ordinance in strikethrough/underline format attached as Exhibit A.

City Staff, at the request of the Historic Preservation Board, has prepared a Zoning Code text amendment to regulations pertaining to historic preservation.

The proposed Zoning Code text amendments will reinsert wording clarifying that the integrity of the historic resource is necessary for designation, provide clarification regarding wood fences, and add a definition for historic integrity.
