WHEREAS, on January 12, 2016, the City Commission authorized negotiations with the following firms as a result of an RFQ process; Hazen & Sawyer, P.C., 300 Engineering, P.A., AECOM Technical Services, Inc., CDM Smith, Inc.; and

WHEREAS, the purpose of these negotiations was to determine compensation that will be paid under continuing contracts with the City; and

WHEREAS, construction projects assigned under these continuing contracts will not exceed \$2,000,000.00 or \$200,000.00 for a study pursuant to Florida Statute 287.055, known as the "Consultants Competitive Negotiation Act"; and

WHEREAS, the Procurement Division of Finance and the Public Works Department have completed their negotiations as to compensation, terms, and conditions under continuing contracts with Hazen & Sawyer, P.C., 300 Engineering, P.A., AECOM Technical Services, Inc., CDM Smith, Inc.; and

WHEREAS, The Chief Procurement Officer in consultation with the Public Works Director recommends that continuing contracts with Hazen & Sawyer, P.C., 300 Engineering, P.A., AECOM Technical Services, Inc., CDM Smith, Inc., be approved; and

WHEREAS, Section 2-650 of the Procurement Code entitled "Authority" authorizes the Chief Procurement Officer, to administer and make recommendations on City contracts;
