The following represents a summary of the items discussed during the Committee meeting.

MEETING AGENDA -

I. CALL TO ORDER

The meeting was called to order at 8:32am.

II. ROLL CALL

All members were present including new member Mr. Greg Blackburn. A quorum was present.

III. OLD BUSINESS

- A. School Improvement Projects (SIP) Updates
- The Coral Gables Senior High track and field are open to the public as long as the CGSH and Ransom Everglades
 are not using it.
- New playground is being installed at Coral Gables Prep.
- B. Special Needs Initiative
- The City Attorney discussed inclusionary opportunities, newly passed legislation, and Commissioner Sosa's desire to contribute funds to create an autism center in the City of Coral Gables.

- Committee members and guests discussed the need for state funding for special needs, specifically job training and education and treating the movement as a grassroots effort or civil rights issue.
- Nature Links presentation by Greg Bush.

IV. NEW BUSINESS

A. Open Seat

- The board discussed the open seat on the Committee, which is a Commission-At-Large appointment.
- Resumes will be reviewed and the Committee will make a recommendation at the October meeting.

B. SCRC "Summer in Review"

- The Committee reflected on the events that took place over the Summer break and brainstormed ways to improve upon them for the future and to build upon the momentum.

 - "Little Carver" Sack Pack Drop-off with the Police Chief
 - District 6 Candidates Forum
 - Coral Gables Prep Walk Thru with Stakeholders

C. Crossing Guards

- The need for a crossing guard at Coral Gables Prep and Carver Elementary was discussed
- Naomi informed the Committee that the budget includes seven crossing guard positions but only two are filled.
- The Police Dept. is working hard to fill these part-time positions.

D. Coral Gables Senior High

- Sam raised Commissioner Slesnick's serious concern over Coral Gables High School receiving a "C" ranking and her request for the Committee's support in helping the school.
- The Committee discussed meeting with the principal, mentorship programs, CUT scores and how student success is measured.
- Important to note that the bar was raised for the 2015-2016 school year and it was the first time that the Florida Standards Alternate Assessments (FSAA) were administered.

E. Teacher Wish lists

- A spirited discussion ensued regarding teacher "wish lists" (non-mandatory requests for school supplies, cleaning supplies, etc. sent home by teachers).
- Meeting attendees shared personal experiences and consensus seemed to be that these lists are unwelcomed and seem to be getting longer.
- Committee asked for reinforcement from the District that additional contributions, beyond a student's individual supply list, are not mandatory.

F. Computer donations

- Committee asked for guidance on how to donate computers to schools
- Comcast may be able to help
- District will follow up with information
